#### 9 **Order of Business**

#### 9.1 | Change of financial year end.

The General Committee supports the proposal to adjust the club financial year from the current **1st September to 31st August** to the proposed **1st January to 31st December**. This change will ensure that all income and payments for one sailing season are contained in the same financial year.

To implement the above changes to the fiscal year end it is necessary to seek AGM approval for change of Club Rule 12.1 by deleting the wording 'ending the last day of August'.

### 9.2 Adoption of Sailing Club Manager to replace Marusa

The General Committee agreed that the club should proceed with adoption of software package Sailing Club Manager to replace Marusa and the membership would be informed at the AGM. The two systems would be run in parallel to the end of December before switching off Marusa.
